

# Amendment

## Section VI. Environmental Assessment

This amendment replaces three Tables in Section VI. Environmental Assessment for STNs MR0000159 and MR0000160; Table VI.F-1, Table VI.G-1 and Table VI.G-2.

### Reason for Amendment:

During a teleconference on March 4, 2020, the FDA requested validation of the data in Table VI.F-1 *Current and Projected Sales (Cigarettes)* of Section VI. Environmental Assessment. Upon review of the table, mathematical errors were found in the fifth-year projected distribution of VLN® King and VLN® Menthol King products. These errors also carried over to the data in Tables VI.G-1 *Estimated Pack Waste Going to MSW* and VI.G-2 *Estimated Shipping Waste Going to MSW*. 22nd Century Group, Inc. seeks to withdraw Table VI.F-1, Table VI.G-1 and Table VI.G-2 from Section VI Environmental Assessment and replace those tables with the tables in this amendment. The amended tables provide corrected mathematical calculations, as well as additional notes to provide further clarification on the data represented therein. In addition to the tables presented below, this amendment also provides the Tables in Excel format with included filename, “2020-03-10\_SectionVIEA-3AmendedTablesF1G1G2.xlsx”
